TERMS OF REFERENCE

Employment Coaching /Counseling Services for Refugees and Host Community Members - Training Consultant

INTRODUCTION

GOAL has been contributing to the urban refugee responses in Turkey since 2016. GOAL's **GREEN Program** aims to improve socioeconomic inclusion, resilience and self-sufficiency of highly vulnerable/excluded women and girls from host and refugee communities (Syrians as well as those living in program locations under the international protection regulation) including nomadic communities and seasonal agriculture workers from both communities through integrated and market driven livelihood opportunities and protection services, such as language courses and vocational skills training on greenhouse production and agriculture; case management (CM) services using coaching approaches, establishment of a women cooperative, protection outreach, information provision and awareness raising; and provision of individual protection assistance services in assistance to persons with special needs.
