#	Clarifications
1	One relevant sample report is required. It is possible that we share an outline of a relevant report while it is impossible to share the full report due to confidentiality terms agreed with our clients, it is likely to be the same for other service providers. Please advise whether an outline of a report would be considered an eligible document or not.
	Unfortunately, full report is required.
2	In terms of stamped & signed reference letters we will add our reference contacts in our prospective application though our concern is that the possibility of not receiving letters by the submission deadline. Please inform us if the letters are a must or only the contacts would be efficient.
	Stamped & signed reference letters are required, as well the RFQ submission deadline is extending, which providing more time for the communication with references.
3	Is it accepted to partner with other companies as enumerators and for data collection in terms of accessing areas of GOAL operations in Turkey?
	No, GOAL Turkey will contract with one service provider to provide the complete service.
4	Could you please clarify whether Ankara should be considered for the qualitative data collection?
	Ankara will not be included in the qualitative data collection.
5	In the case that Ankara is not included in the scope of work for qualitative data collection, could you please confirm that the total number of targeted beneficiaries is 50.142 across the five locations (Gaziantep, Hatay, Mersin, Sanliurfa, and Adana)?
	Confirmed.
6	As "" Team we analyzed the call document and would like to ask a question. We wish to reach the beneficiaries properly in the mentioned cities. Will you provide the contact details of beneficiaries just after the approval of tender?
