

## CALL FOR TENDER ACTED Turkey Instructions to Bidders

Subject: Provision of Washing Machines for Camps and schools in Hatay

Through this tender package, ACTED is requesting a qualified Contractors to submit their proposal for Supplying and Install Washing Machines (Hatay).

## TENDER REQUIREMENTS & TECHNICAL SPECIFICATIONS:

1- Term of Reference: Supplying and Installing Washing Machines (Hatay)

## BACKGROUND

A state of emergency has been established in Hatay, the province most affected by the earthquake that occurred on 6 February 2023 in Turkey. Activities have been implemented to address the urgent health needs of thousands of people (such as toilets, showers, water trucking, water storage, garbage bins, distribution of hygiene items, and hygiene promotion). Due to the difficulties caused by the destruction in the region, access to washing machines remains a challenge, with families washing their clothes in difficult conditions, either manually or using dilapidated machines that pose a risk to their users, increasing the need for new sustainable ways to meet the needs.

Providing easy and safe washing machines is an urgent and necessary need in many locations, especially container cities that house refugees.

## **OBJECTIVE**

The main objective of this initiative is to establish a robust, simplified, and sustainable system that ensures the safety and dignity of families. The primary purpose is to ensure that safe laundry services are provided to earthquake-affected communities, focusing on reliability, efficiency, and meeting the urgent demand for this service.

## **ACTED'S ROLE**

In the aftermath of the Hatay earthquake, ACTED responded quickly and delivered 6 washing stations with 30 washing machines and 30 dryers to the affected population in the Opet camp in Kırıkhan. Based on the feedback from this emergency response, ACTED is now leading a similar solution in Iskenderun-Belen-Kırıkhan-Antakya and Defne.

This new project underscores ACTED's commitment to continue to provide services to create a better reality and to invest in the resilience and long-term sustainability of water resources in disaster-stricken areas. ACTED's unique position, which stems from its extensive experience in WASH, deep understanding of local contexts, and well-established networks within communities and local authorities, enables it to lead this initiative successfully. By leveraging its expertise and resources, ACTED is poised to design, implement, and oversee a project that will ensure the well-being and resilience of the Hatay community in the face of future hardships.



## **SCOPE OF WORK:**

ACTED is committed to providing washing machines to the targeted populations with a holistic approach. This includes delivering and installing these machines, making the necessary connections to ensure smooth operation, enabling local communities to be trained on operating the system, reporting maintenance requests within the warranty period, and implementing strict quality control measures. ACTED ensures compliance with the highest standards, promoting sustainability and the well-being of

the community in the long term.

## **STAKEHOLDERS:**

To ensure the efficient, effective, and successful delivery of services for the implementation of the laundry project, communication, cooperation, and coordination with all stakeholders (local authorities, NGOs, camp management, beneficiaries, suppliers) from inception to conclusion of the operation are targeted.

## 1. <u>ACTED:</u>

## **Responsibilities**:

- Collaborate with local authorities and communities to identify regions requiring access to washing machines.
- Assessment of the laundry needs of affected populations.
- Supervising the installation of washing machines, ensuring compliance with humanitarian principles and standards.

• Supervising the evaluation and monitoring of the effectiveness of the washing machines.

• Coordination with other humanitarian actors and stakeholders to comprehensively respond to laundry needs.

## 2. The supplier:

## **Responsibilities:**

- Installation of the requested number of washing machines per requested locations ensures the machines' functionality.
- Providing and installing washing machines with a minimum 2-year warranty per this ToR's specification.
- Conduct a one-time preliminary inspection (test) after installing each unit to ensure safety and to verify the water washing machines.
- Conduct a single training session for the camp management to impart all necessary information regarding the machines after the installation of each unit.

## 3. Beneficiary Communities:

Engage in training sessions and actively contribute to the maintenance and long-term sustainability of the machines.



## LOCATION

The initiative will focus on the most affected population in Hatay who are settled in official sites represented by container cities, in addition to the teachers who live and teach in these sites.

## **TIMELINE**

The contractor is required to deliver all units to the required locations and make the necessary connections to have the washing machines in functional condition within a **maximum of 10 working days after signing the agreement.**

## **CANCELLATION OF THE TENDER PROCEDURE:**

In the event of a tender procedure being cancelled, bidders will be notified by ACTED. Cancellation may occur where:



- The tender procedure has been unsuccessful, namely where no qualitatively or financially worthwhile Proposal has been received or there has been no response at all.
- The economic or technical parameters of the project have been fundamentally altered.
- Exceptional circumstances or force majeure render normal performance of the project impossible.
- All technically compliant tenders exceed the financial resources available.
- There have been irregularities in the procedure, which have prevented fair competition.

## CONTACTING MODALITY:

Upon awarding the contract to the selected supplier, the formal Purchase Contract between Acted and the supplier shall be bound by the technical specifications and pricing proposed by the supplier in response to the tender. The supplier shall commit to delivering the items in accordance with the agreed price, technical specifications, and works completion timeline as specified in the tender.
