These were addressed **in the second phase** on 03 March 2025 for questions numbered 5 to 6.

#	Clarification Requests and Answers
1	 Do you have architectural drawings/plans for the buildings? No, architectural drawings/plans are not available. However, all necessary details are provided in the BOQ (Scenario) and Technical Specifications. Please refer to these documents for the required information.
2	 Will you send the quantities for each and every building type. Because the BoQs don't mention any quantities. We have shared two types of BOQs. You will need to price only one of them—the BOQ Scenario, which includes all necessary details, including quantities. The other BOQ is provided solely to outline the scope of activities. Please refer to the BOQ Scenario and Technical Specifications for pricing and quantity details.
3	 Are these buildings Container-type prefab units? The activities mentioned in BOQ Activity 1 are intended for your approval to confirm the building type that you approve and can implement. For any future specific projects, all successful bidders from this tender will receive the complete set of drawings and technical documentation.



- Will you send the Building specifications, i.e. wall and roof thicknesses, thermal insulation specs, dimensions?
- Sufficient information is provided in the BOQ. These details are already included in the **Technical Specifications**. Please refer to the **last sheet of the BOQ Scenario**, where you will find more comprehensive details.
 - What will the diameter of the HDPE pipes be? (Reference: Annex III BOQ for WASH Project Scenario, S43-Water Distribution Network)
- The required HDPE pipe diameters are specified in the BOQ Scenario. Please refer to the relevant section in Annex III for detailed information regarding the dimensions and specifications. If further clarification is needed, kindly review the Technical Specifications provided.
 - Considering the changing regulations in Syria, we kindly seek detailed guidance on any new registration requirements or specific processes that XXX (company name) needs to fulfill. As a Turkish limited liability company, we are recognized as a distinct legal entity This means the company can own property, incur debt, sue, and be sued in its own name.
- Could you please inform us whether establishing a local branch is necessary or if this new LTA has specific tax implications and documentation requirements that we should prepare for or provide?
 - The regulatory requirements, including registration, taxation, and documentation, are subject to national laws and evolving policies in Syria. While the LTA itself does not mandate the establishment of a local branch, all awarded bidders must comply with applicable legal and tax obligations in Syria. It is recommended that you consult with relevant local authorities or legal advisors to ensure compliance with the most recent regulations.
